## **Monthly Insurance Assessment and Licensing Committee (IALC) Application Review**

There were 13 insurance applications reviewed in October 2021, comprising 10 new applications and three carried forward applications. Of the 13 applications, 11 were approved and two were deferred.

Registration/licensing of approved insurance entities is subsequent to the IALC application process and may be confirmed in future periods.
