Schedule IVF

The Bermuda Monetary Authority, in exercise of the power conferred by section 6A of the Insurance Act 1978, makes the following Rules:

#### Citation

1 These Rules may be cited as the Insurance (Prudential Standards) (Class 4 and Class 3B Solvency Requirement) Amendment (No. 2) Rules 2022.

# Amends paragraph 6

- 2 Paragraph 6 of the Insurance (Prudential Standards) (Class 4 and Class 3B Solvency Requirement) Rules 2008 is amended as follows—
  - (a) in subparagraph (1) by inserting "IVF," after "IVE,";
  - (b) in subparagraph (2) by inserting "IVF," after "IVE,";
  - (c) in subparagraph (2A)(b) by inserting "IVF," after "IVE,".

# INSURANCE (PRUDENTIAL STANDARDS) (CLASS 4 AND CLASS 3B SOLVENCY REQUIREMENT) AMENDMENT (NO. 2) RULES 2022

#### Amends paragraph 6AB

- 3 Paragraph 6AB of the Insurance (Prudential Standards) (Class 4 and Class 3B Solvency Requirement) Rules 2008 is amended—
  - (a) in subparagraph (2)(a) by deleting the last occurrence of the word "and";
  - (b) in subparagraph (2)(b)(iii)(C) by deleting the full stop and substituting "; and";
  - (c) by inserting the following after subparagraph (2)(b)—
    - "(c) the ECR ratio for the financial quarter;
    - (d) the total quoted bonds and total unquoted bonds allocated by the BSCR rating for the financial quarter;
    - (e) details of any qualifying catastrophic event that occurred during the financial quarter.";
  - (d) by inserting the following after subparagraph (2)—
  - "(2A) For the purposes of subparagraph (2)(e), a "qualifying catastrophic event" means the occurrence of a catastrophic event as recognized by a catastrophe modelling firm approved by the Authority that has publicly estimated industry insured losses resulting from the catastrophe at US\$5 billion or more, or any such event determined by the Authority.".

#### Inserts new Schedule IVF

The Insurance (Prudential Standards) (Class 4 and Class 3B Solvency Requirement) Rules 2008 are amended by inserting after Schedule IVE a new Schedule IVF entitled "Schedule of Risk Exposure" as set out in the Schedule to these Rules.

#### Commencement

5 These Rules are deemed to have come into operation on 1 July 2022.
