## Monthly Insurance Assessment and Licensing Committee (IALC) Application Review

There were 12 insurance applications reviewed in May 2023, comprising of eight new applications and four carried forward applications. Seven of the applications were approved, three were deferred and two were withdrawn.

It is noted that the registration/licensing of approved insurance entities is issued after the IALC application process and may be confirmed in future periods.
