Re: Particulars of ECR Shortfall

With respect to Section 15A(3) of the Insurance Act 1978, the Insurer wishes to provide the particulars relating to its non-compliance with the ECR and TCL requirements for the financial year ended 31 December 2022. The particulars are presented in Appendix A - BMA_BLWW_Capital and Surplus_07202023 ("Notification to the BMA").

Further to the Notification to the BMA from the Insurer on 20 July, 2023, Advantage Insurance Inc., the ultimate parent, and further Advantage International Life Bermuda Limited, the immediate parent of the Insurer, have processed the additional capital contribution ("**Contribution**") of \$2,500,000. The Contribution was received by the Insurer on 24 July 2023. The previous shortfall is now remediated and the Insurer resumes compliance with its ECR and TCL requirements.
