## Monthly Insurance Assessment and Licensing Committee (IALC) Application Review

There were eight insurance applications reviewed in September 2023, comprising of seven new applications and one carried forward application. Four of the applications were approved, three were deferred and one was withdrawn.

It is noted that the registration/licensing of approved insurance entities is issued after the IALC application process and may be confirmed in future periods.
