Monthly Insurance Assessment and Licensing Committee (IALC) Application Review

There were 17 insurance applications reviewed in December 2023, comprising of 15 new applications and two carried forward applications. Of the 17 applications, 12 were approved by the IALC, four was deferred and one was withdrawn.

It is noted that the registration/licensing of approved insurance entities is issued after the IALC application process and may be confirmed in future periods.
