## Monthly Insurance Assessment and Licensing Committee (IALC) Application Review

There were eight insurance applications reviewed in March 2024, comprising of seven new applications and one carried forward application. Of the eight applications, six were approved by the IALC, one was deferred and one was declined.

It is noted that the registration/licensing of approved insurance entities is issued after the IALC application process and may be confirmed in future periods.
