## Monthly Insurance Assessment and Licensing Committee (IALC) Application Review

There were 13 insurance applications reviewed in April 2025, comprising of 11 new applications and two carried forward applications. Of the 13 applications, 11 were approved, one was deferred and one was withdrawn.

The registration of approved insurance entities occurs after the IALC application process has concluded. Therefore, the IALC approval and the registration approval may be rendered in different periods.
